We received 154 grant applications with a combined request of over \$7.3 million for 2017-2018 projects in our three regions. Fifty-two grant applications for Columbia Region projects were received. Wetland restoration and conservation is one of three priorities for the FWCP Columbia Board, so there are numerous wetland projects currently being supported. Wetlands Restored to Help Endangered Frogs

Approximately 3.4 hectares of wetland were restored in November and December 2016 in the Creston Valley through a joint initiative between the FWCP, the

Ministry of Forests, Lands and Natural Resource Operations, and the Creston Valley Wildlife Management Area. The goal of the project is primarily to help the federally-listed endangered Northern Leopard Frog. [Read more](#)
