### Fish habitat restored in Simms Park, Courtenay

Trout, Coho and Pink Salmon are already using recently restored off-channel habitat at Simms Millennium Park near downtown Courtenay. The work was completed at the end of August 2017, and was led by Project Watershed with funding from FWCP and others. [Read more](#)



## Volunteers wanted for planting

While all the construction is complete at Simms Park, Project Watershed is looking for volunteers to plant more than 900 native shrubs, plants and trees at the site. All the planting will take place between October 24 and 28. Anyone interested in volunteering should contact [Project Watershed](#).

## Salmon River Diversion Dam removed

This summer, BC Hydro removed the Salmon River Diversion Dam near Campbell River. The riverbed restoration was completed by mid-September, just in time for the Coho migration. The river edge restoration work was completed in October. There is now unhindered upstream and downstream fish passage for Coho, Chinook and Steelhead. As part of the groundwork for the project, the FWCP Coastal Board endorsed the Salmon River Diversion Fish Passage Committee's recommendations for improved fish passage at the site in 2011. The FWCP uses a [Fish Passage Decision Framework](#) to evaluate the restoration of historic passage for anadromous fish at BC Hydro dams.
