Application deadline ahead: October 27

The deadline for our fall application intake, for projects starting next year, is fast approaching: Friday October 27, 2017, 5 p.m. PDT. Projects must align with the priority actions outlined in our <u>Action Plans</u>. Year five of five for UKEEP: submit your grant application Projects funded under Upper Kootenay Ecosystem Enhancement Plan (UKEEP) in 2018 mark the fifth year of a five-year agreement between the Columbia Basin Trust and the FWCP. Apply by Friday, October 27, 2017, 5 p.m. PDT if you have project ideas that align with the UKEEP Action Plan. FWCP Columbia Region priorities for grant applications

Our Columbia Region Board has identified <u>three priorities for fall 2017</u> grant applications. The Board is encouraging grant applications for projects that result in "on-the-ground" or "in-stream" restoration and enhancement, as well as projects delivered in the North Columbia which includes the areas around Revelstoke and Golden and north to Valemount. <u>See map</u>



33 wetlands evaluated in rapid fashion in the East Kootenay Assessing the health of a wetland is the first step toward simple restoration efforts such as fencing, off-site watering, treatment of invasive plants, and restoration of water levels through mechanical methods. More fish habitat to be made accessible at Heart Creek

In 2015, the construction of an 18-metre long, clear-span bridge at Heart Creek successfully allowed fish to access approximately 250 metres of spawning and rearing habitat. Now, the Ministry of Transportation and Infrastructure (MOTI), with funding from the FWCP, has set its sights on a bigger goal: removal of a second hanging culvert (below) to open up a further 1.2 kilometres of prime fish habitat upstream.
