Columbia Region approves 38 projects for 2019 - 2020

Our Columbia Region Board approved approximately \$5.8 million for 38 projects. The 10 fish and 28 wildlife projects will be delivered by First Nations, agencies, stewardship groups, consultants and others. Together the projects will help build the science-based understanding of species, improve and restore spawning, riparian, grassland and upland habitats, monitor populations, conserve wildlife corridors, assess amphibians, restore wetlands, secure lands for conservation and fill gaps in science and understanding. The projects will benefit Bull Trout, Kokanee, sturgeon, elk, caribou, birds, amphibians, bats and more. [Read our 2019 - 2020 Columbia Region project list](#). \$9.2 million approved for 97 projects in our three regions

Ninety-seven projects are being funded this year by the FWCP to conserve and enhance fish & wildlife in watersheds impacted by BC Hydro dams. The hands-on species and habitat-based projects, along with research and monitoring projects approved for funding, will be delivered across the FWCP's [Coastal](#), [Columbia](#) and [Peace](#) regions. 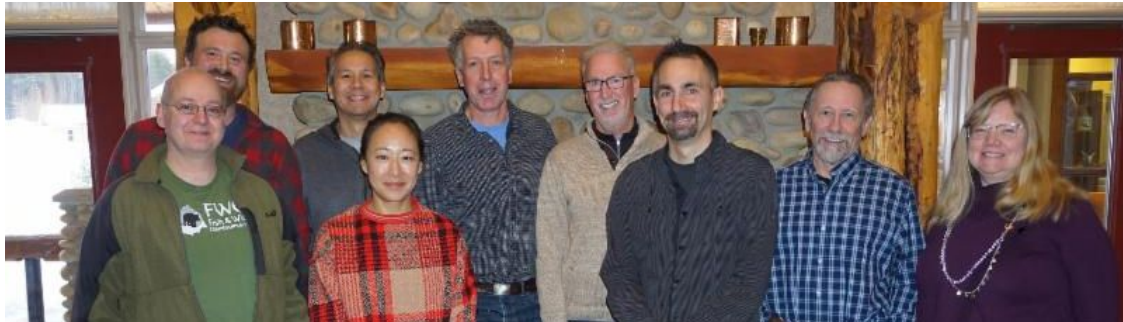
