Our updated [2019 Columbia Region Action Plans](#) are now available. These updated ecosystem-based Action Plans define Priority Actions eligible for projects, and are based on input from agencies, First Nations, fish and wildlife stakeholders, and local citizens.

We had more than 60 group and 1:1 discussions, and hosted 18 public engagement events to talk about priorities, emerging issues and our Action Plans. It's easy to apply for an FWCP grant

1. Review our updated, [2019 Columbia Region Action Plans](#);
2. Develop a project idea to fulfill an action in any Action Plan(s);
3. Login to our grant management system at fwcp.ca/apply-for-funding; and
4. Start your application, and submit by Friday, Oct. 25, 2019 by 5 p.m. PDT.

Who can apply?

Any group, government agency, First Nation, business, or individual that can meet our mandatory requirements (e.g. WorkSafeBC and commercial general liability insurance) is eligible to receive an FWCP grant. In the past, First Nations, municipal, provincial, or federal agencies, stewardship groups, consultants, and educational institutions have been approved for FWCP grants.
