## Message from our board co-chairs

Welcome! Thanks for taking a moment to read our chair's message! As co-chairs of the Fish & Wildlife Compensation Program (FWCP) Peace Region board, we are pleased to share our annual report with you and reflect briefly on 2024-2025.

Projects: In fiscal year 2024-2025, our board approved approximately \$1.9 million for 25 fish and wildlife projects. Final reports from these projects are available at fwcp.ca/results. Our annual summary of project outcomes and results is also posted there so everyone can see how the funding we approve each year compensates for the impacts on fish and wildlife. Read our project list at the end of this report to learn more about the projects approved by our board. They addressed many of our conservation priorities, including fish passage and caribou habitat restoration, to name a few.

Many of the projects underway this year are of cultural and conservation importance to our Indigenous partners. These include projects supporting moose habitat restoration, filling data gaps on bull trout abundance, assessing wolverine density and abundance, and more.

In late 2024, our First Nations partners started discussing ideas for a collaborative project supported with FWCP funding. This unique collaborative project will see participating Nations lead moose habitat enhancement work that will support sustenance harvest, food sovereignty, amongst other values important to the Nations.

Audit update: We continued to implement recommendations from our 2019 independent evaluation and financial audit this year, including the submission of a completion report. See page 5 for an overview.

We completed a logic model—as recommended in the audit—to guide our strategic approach to funding projects and track our progress through a performance measurement strategy. Both of these initiatives provide a framework for a new and more flexible approach to funding projects and enable tracking of performance metrics that relate back to our mandate. These will get underway in 2025-2026.

Board news: This year, we said goodbye to board members Gord Haines, Jessica Wiens, Chris Addison, Heather Middleton, Deeanna Izony, Rosemarie Sam and Ray Pillipow. We welcomed Al Mottishaw, Stephanie Bellehumeur, Alyssa Lepka, Luke Gleeson, and James Jacklin.

### 1. Overview

#### **FWCP Peace Region**

The FWCP's Peace Region was established in 1988 to support the conservation and enhancement of fish, wildlife, and habitats in watersheds impacted by construction of the W.A.C. Bennett and Peace Canyon dams, and the creation of the Williston and Dinosaur reservoirs.

#### **Compensating for dam impacts**

BC Hydro has water licence obligations in the Columbia and Peace regions and has made voluntary commitments to address the impacts of dams in the Coastal Region. BC Hydro fulfills the applicable obligations through the work of the FWCP. The FWCP does not compensate for Site C impacts to fish and wildlife. Site C's water licence obligations require BC Hydro to establish separate environmental monitoring, mitigation, and compensation programs and, under the water licence, BC Hydro will report to the Comptroller of Water Rights on these programs.

With annual funding from BC Hydro, the Fish & Wildlife Compensation Program (FWCP) conserves and enhances fish and wildlife in watersheds impacted by 31 BC Hydro dams. The FWCP directs those funds toward priority actions across its three regions: Coastal, Columbia, and Peace.

The FWCP is governed through a framework that recognizes the regulatory accountabilities of agency partners (i.e., BC Hydro, the Province of B.C., Department of Fisheries & Oceans Canada: DFO). The framework also ensures public and Indigenous participation in decision-making, project planning and delivery. Independent regional boards review, evaluate, and approve funding for all projects. Our boards include representatives from each of our FWCP partners: First Nations (21 seats), public interest holders (9), BC Hydro (5), and the Province of B.C. (5). While DFO has the opportunity to participate on the Peace Region board, it currently does not. Appendix B shows the full list of board and committee members for our Peace Region during F25. When it comes to decision-making, input from each board member is given equal consideration through collaborative discussion. Learn more at fwcp.ca/our-story.

Since 1988, BC Hydro has provided more than \$230 million to the FWCP to compensate for dam impacts, and the FWCP has funded more than 2,500 projects across our three regions. Our Peace Region has received more than \$47 million since it started, and typically funds between 20 and 30 projects each year.




Figure 1.1: Map of the FWCP's Peace Region

### 2. Our strategic approach

#### **VISION AND MISSON**

Our vision is for thriving fish and wildlife populations in watersheds that are functioning and sustainable. Our mission is to compensate for fish and wildlife in watersheds impacted by BC Hydro dams.




Figure 2.1: Strategic framework. The projects we fund align with our regional action plans, reflect our strategic objectives, and align with our mission and vision.

We take a forward-looking, ecosystem-based approach that defines the desired outcomes and takes actions to restore, enhance, and conserve priority species and their habitats, in alignment with our strategic framework as in figure 2.1, below. More details on our three strategic objectives can be found in the Governance Manual.

#### **ACTION PLANS**

Our action plans guide FWCP investments in fish and wildlife projects. They are referenced annually by our regional boards to track progress toward implementation, set priorities, and guide decision-making in setting out and approving the annual operating plan for each region. Actions in our action plans are eligible for FWCP funding and align with our vision, mission, and geographic scope.

In our Peace Region, we currently have four ecosystem-based action plans. F25 projects approved by our Peace Region board align with the priority actions identified in the Peace Region action plans:

- 1. Cross-Ecosystem Action Plan
- 2. Riparian & Wetlands Action Plan
- 3. Rivers, Lakes, & Reservoirs Action Plan
- 4. Uplands Action Plan

#### **UPDATE: EVALUATION AND FINANCIAL AUDIT**

In 2019, an independent third-party evaluation and financial audit, as required in our Governance Manual, was completed. The auditor made nine recommendations to refine, support, and strengthen our approach to conserving and enhancing fish and wildlife in watersheds impacted by BC Hydro dams. Since 2019, the FWCP team has been methodically working on the recommendations, and many of them have been completed or nearing completion. See website for more details.

## 3. Financial report

#### **APPROVED BUDGET AND EXPENDITURES**

Our Peace Region board allocates annual funding toward fish and wildlife projects, and other operational tasks, as shown in Figure 3.2. These allocations form the annual operating plan. Any unallocated funds are carried forward as uncommitted available funds for future spending.

The annual funding provided by BC Hydro to the region for the year was \$1,835,075. Our Peace Region board approved a budget of \$2,644,628 for this year, utilizing unspent surplus funds from previous years.




Figure 3.1: FWCP Peace Region financial summary on April 1, 2024. The F18 remaining commitment to spend of \$148,200 is related to a land protection project that was delayed due to issues with acquiring one parcel of the intended conservation lands. The remaining commitment to spend in F19 and F21 were related to projects that saw delays due to COVID-19 and other weather events and personnel shortages that prevented project activities from occurring. The F18, F19 and F21 commitments to spend will be spent in F26.

Figure 3.1 shows nearly \$4.28 million available to our Peace Region as of April 1, 2024. This comprises the approved budget of approximately \$2.64 million, the uncommitted available funds of approximately \$492,593, and the remaining prior-year funding commitments from F24 to F18 of approximately \$1.14 million.

Figure 3.2 illustrates the approved budget for F25 as of April 1, 2024. Funding for wildlife projects accounted for 43% of the budget, while funding for fish projects accounted for 28%. Administration accounted for nearly 12% of the budget, and First Nations engagement a further 6%. The remainder comprised communications, strategic initiatives, including logic model development and planning for revising the action plans, as well as Seed and Community Engagement Grants. Peace Region expenditures up to the end of the fiscal year (March 31, 2025) are shown in Table 3.1. This reflects a snapshot of actual and planned payments made related to this year's finances. Funding allocated each year may not be fully expended by year-end, and as shown in Table 3.1, F25 allocated funds not yet expended by March 31, 2025, are labelled as planned payments.

Occasionally, projects come in under budget (unspent funds in Table 3.1)1. Funds not spent during the fiscal year will be carried forward as unspent surplus budget and made available for new spending in future fiscal years.




Figure 3.3: Financial summary of the FWCP's Peace Region, as of March 31, 2025 (end of fiscal year)

In addition to the planned payments of \$1,047,163 from F25, the balance of prior-year funding commitments anticipated to be spent in F25 was approximately \$99,000 from F24, \$12,000 from F23, \$8,000 from F22, and approximately \$148,000 from F18, with \$774,039 available in uncommitted funds (Figure 3.3).

<sup>1.</sup> The end of F25 and the year-end deadline for project reporting are on the same day. Therefore, reports (and potentially) statements of accounts are not reviewed and accepted until after the March 31 deadline. Many final payments for F25 projects are processed in the first few months of F26, and unspent funds are allocated for future spending.

### 4. Project funding and grants

#### PROVINCIAL PROJECT FUNDING

This year, our three regional boards approved 95 projects for a total FWCP contribution of approximately \$10.4 million. The total value of these projects, including leveraged funding from other organizations and in-kind resources, was nearly \$23.7 million.

#### **PEACE REGION PROJECT DELIVERY**

In our Peace Region, the FWCP supports the delivery of fish and wildlife projects in a variety of ways, including grant applications and directed projects. Twenty-five projects were approved by the end of the fiscal year, for \$1,880,145 from our Peace Region board.

#### **Grant-based projects**

The FWCP's annual grant intake opens each summer and closes in the fall. All grant applications go through a three-stage review process. For more details, visit our FAQs at fwcp.ca/apply-for-funding/.

Grant applicants are required to develop a project idea that aligns with one or more priority actions in any action plan and that will achieve the intended outcome. Each priority action in our action plans is identified as Open, Open/Directed, or Directed. The proposed project must be aligned with an Open or Open/Directed priority action to be eligible for a grant.

In our Peace Region, all grant applicants are required to submit a notice of intent (NOI) before submitting a full application. The NOI is an important part of our commitment to strengthen engagement with First Nations. It helps inform First Nations about proposed projects and is the basis for identifying opportunities for First Nations perspectives on and engagement in the projects. It also helps our Peace Region manager provide additional guidance before grant applications are completed.

Of the 25 projects approved for the year, 18 were grant-based: six for fish and 12 for wildlife, for a total of \$1,253,682. Funding allocation was 37% (\$468,560) for fish projects and 63% (\$785,123) for wildlife.

The FWCP encourages grant applicants to seek additional funding sources (e.g., other funding agencies and in-kind contributions) to leverage FWCP funding contributions. We recognize the value of partnerships in helping to plan, deliver, and fund projects. We encourage grant applicants to build funding and project partnerships into their projects. In F25, as stated, the FWCP funding allocation for grant-based projects was approximately \$1.25 million. As a result of financial partnerships and in-kind contributions, the total value of the projects was just over \$3.78 million. In other words, for every \$1 invested by the FWCP, others contributed nearly \$2, greatly increasing the value of the FWCP's investment overall.

#### **Directed projects**

Directed projects provide our Peace Region board the opportunity to direct funds to regional priorities with a specific scope of work issued through procurement processes (e.g., direct award, request for proposal).




Figure 4.1 F25 directed project funding compared to granted-based project funding.

Approximately \$626,000—nearly twice as much as the previous year was approved for seven directed projects: three fish projects (just over \$272,000) and four wildlife (almost \$355,000). The directed projects included improving fish passage, UNBC Colloquium Presentation Series, Mugaha Marsh Banding Station, Arctic grayling enhancement opportunities, and moose habitat enhancement. Figure 4.1 shows the breakdown of funding versus directed projects compared to grantbased projects. For the complete list of all the projects funded, see Appendix A.

#### Projects delivered by proponent type




Figure 4.2: Funding for F25 Peace Region projects by lead proponent type \*Includes First Nations-owned businesses and First Nations-led organizations

More than half (nearly 53%) of the project funding went to First Nations, with 44% allocated to projects led by non-government organizations. Figure 4.2 shows the allocation of funding by proponent type in F25.

#### Approved projects by action type

Priority actions in our Peace Region action plans are grouped into five broad action types:

- 1) research & information acquisition
- 2) habitat-based
- 3) species-based
- 4) monitoring and evaluation
- 5) land securement




Figure 4.3: F25 project funding by action type

This year, 61% of funding went towards research and information acquisition projects and 37% to habitat-based projects. The funding split by action type is illustrated in Figure 4.3 below.

There were no funds directed towards species-based actions. At the start of the year, \$100,000 was set aside for land securement, however, there were no projects approved for this category, so these funds are rolled forward for future land securement initiatives. #### Projects delivered by sub-region




Figure 4.4: F25 project funding by sub-region

Figure 4.4 shows the funding approved for projects this year by subregion. Funding breakdown was 37% for the Parsnip sub-region and 34% basin-wide.


#### **Community Engagement Grant**

The goal of the Community Engagement Grant is to provide small grants of up to \$1,500 to support activities that align with our strategic objectives. Groups can apply for a Community Engagement Grant at any time during the year, while funds are available.

An initial budget of \$5,000 was set aside for Community Engagement Grant funding in our Peace Region. Six applications were received, and five were approved, totalling \$5,052. The complete list of approved Community Engagement Grants is shown in Table 4.2
