Apply Now! Funds Available for Fish and Wildlife Projects

We fund fish and wildlife projects that align with our Action Plans. Your idea for a project to conserve and enhance local fish and wildlife may be eligible for funding. Read our Action Plans and download your funding application at our <u>website</u>. **Funding applications are due November 3, 2014.** Email us for support to develop your idea and funding application.

Pick From Three Funding Options

- 1. Seed Project funding up to \$5,000 to assist applicants to develop a large project funding application in a subsequent year that aligns with FWCP's Action Plans.
- 2. Small project funding new this year for projects that align with FWCP's Action Plans and have a total project cost of

less

than \$20,000.

3. Large project funding for projects that align with FWCP's Action Plans and have a total project cost of more than \$20,000.

Action Plans Guide Our Work

The FWCP has developed Action Plans for the watersheds where BC Hydro operates. These Plans guide our investments in fish and wildlife and address priority actions to carry out conservation and enhancement projects. Coastal Board members recently toured FWCP-projects in the Bridge and Seton Watersheds



including visits to the Powerhouse Foreshore Restoration site (left) and the Seton Corridor Project near Lillooet with the Splitrock Environmental team. They also heard presentations from proponents who are working on projects to better understand and support habitat for grizzly bears, mule deer, bats and wolverine. Tours like this help Board members get familiar with the watersheds where FWCP is active and the dedicated proponents who are conducting valued projects with FWCP funding support.


