Grants available for fish and wildlife projects

We're now accepting grant applications for fish and wildlife projects that align with our updated 2020 Peace Region action plans. All grant applicants in our Peace Region must submit a [notice of intent](#) (NOI) by Friday, September 11, 5 p.m. PDT. The NOI helps inform First Nations about your proposed project and allows our Peace Region manager to provide you with additional guidance before submitting your grant application. Grant applications are due by 5 p.m. (PDT) on Friday, October 30, 2020.

Final updated Peace Region action plans now available

Updated 2020 [Peace Region action plans](#) are now available. The ecosystem-based action plans have been updated to reflect emerging issues and ecological priorities. The action plans define priority actions eligible for funding to help conserve and enhance priority species, upland areas, wetland and riparian areas,

as well as rivers, lakes, and reservoirs. A new cross-ecosystem action plan includes several broad actions that apply to more than one ecosystem. A new overview document provides important context for our work in the region and serves as a guide to our action plans.
